

IMPORTANT DEVELOPMENTS WITH REGARD TO DEPARTMENT OF PERSONNEL & TRAINING FOR THE MONTH OF JULY, 2017

1. Inaugural session of Assistant Secretaries (IAS officers of 2015 batch) was held on 3rd July, 2017. Addressing on this occasion, Hon'ble Prime Minister motivated these IAS Officers to bring out positive changes in the system. Hon'ble MoS (PP) also addressed these Assistant Secretaries.
2. Interactive session of Assistant Secretaries of 2015 batch was held on 14.07.2017 at CSOI, Vinay Marg, New Delhi. Presentations were made by experts of ISTM and MeITY / Banks on "File Management System" and "Digital Payments in India" respectively.
3. Interactive session of Assistant Secretaries of 2015 batch was held on 21.07.2017 at Vigyan Bhawan, New Delhi. Presentations were made by heads of Scientific Ministries / Departments / Organizations on various scientific achievements / opportunities / challenges ahead. Presentation was also made by Director General, DGS&D and CEO (GeM) on Government e Market Place (GeM). Assistant Secretaries made valuable suggestions to improve various aspects of GeM.
4. Clarification on benefit of Pay fixation at the time of regular promotion/ grant of Non-functional Scale under Modified Assured Career Progression Scheme for the Central Government Employee was issued vide O.M. No. 35034/3/2008-Estt(D)(Vol.II) dated 04.07.2017.
5. Instructions on making available scores and rankings of candidates in recruitment examinations on the NCS portal of Ministry of Labour and Employment were issued vide O.M. No. 39020/01/2016-Estt(B) dated 19.07.2017.
6. As per the acceptance of recommendations of 7th CPC, order for payment of Special Allowances for officers belonging to North-East Cadres of AIS officers and Special Duty Allowances at the revised rates of 20% and 10% respectively was issued vide letter No. 11022/1/2017-AIS -11 dated 25th July, 2017.
7. Instructions of availability of option for fixation of pay on promotion from the Date of Next Increment (DNI) in the lower post and method of fixation of pay from DNI, if opted for, in context of CCS (RP) Rules, 2016 has been issued vide O.M. No. 13/02/2017-Estt.(Pay-I) dated 27th July, 2017.
8. Decision of Central Government to abolish Sumptuary Allowance in all the Training Establishments/Academies/Institutes was conveyed to all Ministries/Departments/CTIs/ATIs vide O.M. No. 17014/2/2014-Trg.(7th CPC) dated 25th July, 2017.

9. Instructions on Extension of time-limit for forwarding of 7th CPC related anomalies by the Staff-Side NC(JCM) and for their disposal by the National Anomaly Committee were issued Vide O.M. No. 11/2/2016-JCA dated 17.07.2017.
10. Instructions were issued regarding Grant of Paid Holiday during Bye –Election to fill the clear vacancies in the State Legislative Assemblies of Arunachal Pradesh and Nagaland on 29.07.2017 vide O.M. No. 12/3/2016-JCA-2 dated 28.07.2017.
11. Guidelines regarding fixation of pay of candidates working in Public Sector Undertakings etc., recommended for appointment by the Commission by method of recruitment by selection were issued vide O.M. No. 12/3/2017-Estt.(Pay-I) dated 28.07.2017.
12. Total 31 training programmes were conducted at ISTM including 01 CSS-CTP (L-B) and 01 CSSS-CTP (L-III) programmes. The number of participants in these programmes was 1440.
13. Cadre Review of IPS (Tripura) is issued vide Notification dated 06.07.2017.
14. Instructions on revised allowances of HRA and others in respect of AIS officers was issued vide this Department's O.M. No. 11022/1/2017-AIS-II dated 25.07.2017.
15. Appointment's Committee of the Cabinet (ACC) has approved appointments in 09 cases in various Schedule A & B Central Public Sector Enterprises (CPSEs). Further, Twenty Four (24) appointments of Chairpersons/Members in various Tribunals/ Statutory Bodies/ Authorities/ Commissions, Six (06) appointments of Chief Executives in Autonomous Bodies, Five (05) proposals of Premature repatriations, Two (02) proposals of Appointment of PS to Ministers, One (01) proposal of Appointment of OSD to Ministers, Two (02) proposals of Extensions, One (01) proposal of Curtailment of tenure and One (01) proposal of Appointment (Non-CSS) has been approved by the EO(MM-I)-Cabinet Secretary/ACC. Further Two (02) officers have been appointed as DCO, One (01) officer has been appointed as CVO and Ten (10) officers have been retained on offer under the Central Staffing Scheme.
16. Blood Donation Camp was organised by DOP&T in association with the Indian Red Cross Society, New Delhi at Nirman Bhawan, New Delhi on 19.07.2017 and 53 employees donated blood in this camp.
